The Graduate School of Pharmaceutical Sciences, Kumamoto University recruits international students who wish to enroll in the basic or four-year doctoral course of HIGO Program. The English language is used for all classes and research instructions in this program.

### **Qualification for applicants**

**【Master's Degree HIGO Program Basic Course】**

#### **1) Educational Background:**

All applicants should have completed 16 years of educational and research experience. The applicants must satisfy at least one of the following eight educational backgrounds and research experience:

- ① Applicants must be graduated from a four-year medical, dental, pharmaceutical or veterinary school outside of Japan, or expected to graduate from such a school by March 2016 to be eligible to enroll in April 2016.
- ② Applicants must have finished 16 years of school education by taking correspondence courses provided by the school outside of Japan, while residing in Japan, or expected to finish such process by March 2016 to be eligible to enroll in April 2016.
- ③ Applicants must have completed at least 16 years of education (recognized by the Japanese Minister of Education and Culture, Sports Science and Technology) in their home countries. Welcome to apply are those who are prospective graduates by March 2016 for April 2016 enrolment.
- ④ Applicants from a specified course of vocational schools (limited to those who must have studied over 4 years and those who have fulfilled the requirements authorized by the Minister of Education and Culture, Sports, Science and Technology) must have completed the course designated by such authority on the day after the designated day (those who are prospective graduate by March 2016 are eligible to enroll in April 2016 are included).
- ⑤ Applicants must be approved by the Minister of Education, Culture, Sports, Science and Technology based on the No.5 Announcement of the Ministry of Education, Science, Sports and Culture in 1953.
- ⑥ Applicants must be recognized as having attainment of equal or a greater academic ability than other graduates of our university in the qualification examination provided

by Graduate School of Pharmaceutical Sciences, Kumamoto University and reach 22 years old by March 2016, to be enrolled in April 2016.

- ⑦ Applicants must have studied in our university more than three years, and be recognized to have achieved excellent academic ability in the credits provided by the Graduate School of Pharmaceutical Sciences, Kumamoto University.
- ⑧ Applicants must have completed a 15-year education outside of Japan, or must have finished 15 years of education through correspondence education provided by the school outside of Japan while residing in Japan, and must be recognized to have achieved excellent academic standing by the Graduate School of Pharmaceutical Sciences, Kumamoto University.

#### 【Doctoral Degree HIGO Program Four-year Course 】

##### 1) **Educational Background:**

All applicants should have more than 18 years of educational background and research experience, and should satisfy at least one of the following six requirements:

- ① Applicants must have graduated from a six-year medical, dental, pharmaceutical or veterinary school outside of Japan, or be expected to graduate from such a school by March 2016, to be eligible to enroll in April 2016.
- ② Applicants must have graduated from a five-year medical, dental, pharmaceutical or veterinary school outside of Japan, and must have conducted research for more than 1 year in a university or a research institute outside of Japan, after completion of formal education, or be expected to finish such a process by March 2016 to be eligible to enroll in April 2016.
- ③ Applicants must be graduated from a four-year medical, dental, pharmaceutical or veterinary school outside of Japan, and must have conducted research for more than two years in a university or a research institute outside of Japan, after completion of formal education, or be expected to finish such a process by March 2016 to be eligible to enroll in April 2016.
- ④ Applicants must hold a Master's degree from an institution which has a two-year education program outside of Japan, after completion of 16 years of formal education outside of Japan, or be expected to meet this requirement by March 2016, to be

eligible to enroll in April 2016.

- ⑤ Applicants must have conducted research for at least two years in a university or a research institute outside of Japan, after completion of 16 years of formal education outside of Japan, and be recognized as having an education that is equivalent to a Master's degree.
- ⑥ Applicants must be recognized by the Graduate School of Pharmaceutical Science, Kumamoto University as having attainments equal to or greater than a Master's degree.

- 2) **Health:** Applicants must be in good physical and mental health.
- 3) **Language skill:** Applicants must have attained the minimum required score in one of the following test:
  - ① TOEFL-iBT
  - ② TOEFL-CBT
  - ③ TOEFL-PBT
  - ④ TOEIC
  - ⑤ IELTS
- 4) **VISA:** Applicants must have a student visa when coming to Japan.

### **Term of Education**

- Basic Course: from April 2016 to March 2018 (two years)  
Specialized Course: from April 2018 to March 2021 (three years)
- Four- year Course: from April 2016 to March 2020 (four years)

### **Scholarship Benefits**

The Basic Course student can receive scholarship of 200,000 yen/month, and 4-Year Course student can also receive scholarship of 200,000 yen/month in 2015. However, it should be noted that, since the issuance of the current leading program subsidies are scheduled until 2018 academic year, it does not have to be determined for the scholarship of April 2019 or later.

### **Screening Procedure**

- 1) Applicants must choose one of the research leaders in the Graduate School of Pharmaceutical Sciences, Kumamoto University, and must obtain permission to

- apply for this program from his/her prospective supervisor in advance.
- 2) Applicants must obtain all application information and form through the Internet by themselves. After filling in all the forms, they must send them to their prospective supervisor of the Graduate School of Pharmaceutical Sciences.
  - 3) The prospective supervisors must submit all application forms to the committee for this program before the deadline for application.
  - 4) The committee will provide examinations for those who apply to the program. The main parts of examination are an English test (TOEFL, TOEIC, IELTS), an essay and an interview.
  - 5) The interview is conducted by three committee members. When applicants would like to have an Internet-based examination, please refer to "Instruction for Internet-based interview", and find the details. If foreign applicants are in Japan on July 4, 2015, when the doctor course examination is held in Japan, they also can take interview on this day in Japan.
  - 6) The final score of the examination is based on the total scores of the English test, essay and interviews by three committee members.

### **Entrance Date**

April 1, 2016

### **Academic Degree**

Doctor of Philosophy degree (Ph.D.) is conferred to students who successfully fulfill all the requirements of the basic and the specialist courses, or the 4-year course of the HIGO program.

### **Application Deadline**

The research leaders or prospective supervisors of the international students should collect and submit all the required documents, shown below, for application to the Student Affairs Section, Graduate School of Pharmaceutical Sciences by June 16 (Tuesday), 2015.

**Examination Date:** July 4 (Saturday), 2015

### **Required documents**

Applicants should submit the following documents:

- 1) Application form for admission (Form 1)

- 2) Photo ID card, examination card, certificate of residence (Form 2)
- 3) One photograph (Paste photograph of the applicant taken within the last three months on the Photo ID card. It must be a 4 cm × 3 cm headshot with no hats or other headgear.)
- 4) A certificate of graduation or the certificate to show its prospective
- 5) Academic record issued by the university attended
- 6) Written statement of reasons for the application (Form 3)
- 7) Examination Fee (30,000 yen)
- 8) A copy of applicant's English examination score (Either of the following: TOEFL iBT score 50 or higher, TOEFL CBT score 143 or higher, TOEFL PBT score 463 or higher, TOEIC score 480 or higher, or IELTS score 4.5 or higher)
- 9) A letter of agreement from the applicant's employer, if the applicant is an employee.
- 10) Letter of recommendation (Form 4)

### **Additional Statements**

- 1) Applicants are urged to discuss a research plan with their prospective supervisors of the Graduate School of Pharmaceutical Sciences, Kumamoto University in advance.
- 2) All documents should be typewritten on A4 sized paper.
- 3) Applications with incomplete information, or those submitted after the deadline will not be accepted.
- 4) No application materials will be returned to the applicants.

**Note**

- 1) Students will not be allowed to continue studying at Kumamoto University if any of the following occurs:
  1. False statements appear in the application form.
  2. The student is expelled from university by violating school rules or the student is considered to be unlikely to complete their academic requirements.
  3. The student leaves the university or transfers to other university.
  4. The status of the student visa is changed to another type of visa.
  
- 2) Applicants are advised to be familiar with the Japanese culture, habit, climate, and the university system before coming to Japan. Having Japanese language skills for daily life would also be recommended.
