Program for Fostering Innovators to Lead a Better Co-being Society

Application Guidelines for AY2024

At Kumamoto University, we are providing support for doctoral students to create an environment where they can focus on research and to assist in shaping career paths after completion. This support is possible with funding from the Japan Science and Technology Agency (JST) and their Support for Pioneering Research Initiated by the Next Generation (SPRING) program.

Starting from April 2024 (AY2024), our aim is to further improve the motivation to enter doctoral study and the fostering of doctoral candidates with advanced research capabilities. To achieve this, we will implement the "Program for Fostering Innovators to Lead a Better Co-being Society" (the Better Co-being Program).

In addition, if selected for the "Next Generation AI Human Resources Development Program" (the "BOOST Program") implemented by JST, we plan to implement the "Global Doctoral Human Resource Development Program for Leading the Field of AI" (hereinafter referred to as the "Guide4AI Program") with the aim of fostering outstanding doctoral talents in interdisciplinary areas, with AI as the core subject. Applicants interested in both programs can apply for both (duplicate applications are possible). Please refer to the separate Guide4AI Program recruitment outline for further details.

For AY2024's Guide4AI Program, selection will be made from among those who have applied for this program. Additionally, if applying to both programs and meeting the requirements for both, priority will be given to acceptance into the Guide4AI Program.

1. Number of Students Accepted for Admission

31 students (Limited to those who entered the first year of a 3- or 4-year doctoral course on April 1, 2024)

2. Eligibility for Application

Doctoral course students enrolled in the graduate schools listed below may apply (however, those taking an absence from university as of April 1st, 2024, are not eligible):

- Graduate School of Science and Technology
- Graduate School of Social and Cultural Sciences

- Graduate School of Medical Sciences
- Graduate School of Health Sciences
- Graduate School of Pharmaceutical Sciences

Applicants must also fulfil the conditions below:

- (1) Students who entered the first year of a 3- or 4-year doctoral course on April 1, 2024
- (2) Students who are NOT supported by the following may apply:
 - JSPS Special Research Fellowship
 - MEXT Scholarship
 - Foreign students who are supported by scholarship programs in their home country
- (3) Students who are deemed to NOT be receiving a stable income which is sufficient to meet living expenses, such as an income from a company or university position may apply (a stable income is classed as approximately 2.4 million yen/year)
- (4) Students who have never received a disciplinary action stipulated in Kumamoto University's Regulations
- (5) Students who can take full part in the program throughout the support period

3. Support Amount

Living expenses: 200,000 JPY/month

Research grant: 200,000 JPY/year

- * The living expenses and research grant amount are subject to change depending on government policies and budget conditions
- * Living expenses and research grant will be supported only for official duration of respective courses in the university.
- * The first payment of living expenses for those accepted by the program will be made in June as a lump sum for the period from April to June. It will be paid monthly thereafter.
- * In line with university rules, the research grant can be used on necessary goods for research, travel expenses, etc. The research grant will be managed and distributed by the affiliated laboratory.
- * Furthermore, if your living expenses payment beings or ends during the middle of a month, the amount paid in that month will be determined by the university pro rata.
- * The amount equivalent to living expenses is treated as miscellaneous income under tax law and is subject to income tax and residential tax.
 - For the health insurance and dependent allowances, please contact the person in charge at the workplace of head of the family (e.g. parents).
 - Please contact your local tax office for the regulation of income tax for dependents.
- * If you are an international student who has not yet arrived in Japan, the start of support (payment of living expenses and allocation of research expenses) will be after your arrival

in Japan.

4. Program Terms

Students who are selected for the program must comply with the following terms. In the case that a student does not comply with any of these terms, payment of living expenses and the research grant may be suspended.

- (1) Students should focus on their research activities.
- (2) Students should attend the courses on research ethics and compliance provided by the university.
- (3) Students should get confirmation of enrollment every month.
- (4) Students should submit a research plan and a research report every year to the Program Supervisor.
- (5) Throughout the support period, participants are required to complete the following educational programs as defined by this program:
 - (a) Participate in one or more overseas training sessions during the period of support, or obtain credits for one of the following courses listed in the appendix (pg. 6) titled "Doctoral Cooperative Education through Research Internships", "HIGO Governmental Internship", or "HIGO Business Internship"
 - (b) Attend all colloquium and reporting sessions
 - (c) Take credits for this program (see appendix, pg. 6) in accordance with the course completion procedures
- (6) Register with Consortium system and JGRAD

5. Application Procedures

- Written statement for reason of application (upload as PDF)
 *If you wish to apply for the Guide4AI Program, additional documents are required
- · Research Plan (upload as a PDF)
- · Scores of external English examinations such as TOEIC, etc.
 - If you have them, attach them to the back of the research plan. If you do not have them, you do not need to attach anything

(3) Application Period

April 5th (Friday) – April 19th (Friday), 2024 by 12:00pm

6. Selection Procedure and Notification of Results

(1) Selection will be based on an applicant's submitted application and by interview.

(Points to consider in your application)

Reasons for application (clarity of motivation and ambition, vision for career path, motivation for research, abilities for cross-disciplinary training and research, and learning in different fields, training of cross-disciplinary research ability, and ambition and motivation for challenging career paths, etc.)

Research plan (scientific contribution, objectives and feasibility of research, clarity of application form, social impact, potential for integration with other fields, etc.)

English language score from an external examination

(Points to consider during your interview)

Motivation, reasons for one's application, research plan, career vision, etc.

- (2) The language used for the written examination and interview shall be Japanese or English.
- (3) Interviews will be conducted via Zoom, and they are planned to be held between May 7th (Tues) to May 13th (Mon). We shall inform you about the exact date and time of the interview via the email address you provide in your application.
- (4) The results of the selection process shall be announced at the end of May.

7. Handling of Personal Information

- (1) Personal information contained in the application documents will be used for selection of program students and other purposes related to the program.
- (2) Personal information such as test results used for the selection of program students will be used for the compilation and analysis of selection results and for the investigation and analysis of selection method.
- (3) In order to carry out (1) and (2), some aspects may be outsourced to an external company. In such a case, after making an appropriate contract for careful handling of personal information, all or part of the acquired personal information will be provided to the company.

8. Orientation for the Program

9. Caution

- The names of selected students will be posted on the university homepage.
- After submission, as a general rule you will not be allowed to make any changes to your application.
- Applications will not be returned.
- Applicants who include false information in their application will be rejected and may be rejected even after the selection process has finished.
- A follow-up survey of selected students will be conducted. Students will be asked to participate in these surveys for up to 10 years after completion of the program.
- After selection by the program, students must submit a certificate of completion of research ethics education (eAPRIN or eL CoRE) conducted by the university. You will receive information from your affiliated department, so please make sure to take the course as soon as possible.
